CONTRACT FOR SPECIALIZED SEXUALITY EDUCATION SERVICES ATHENS COUNTY BOARD OF DEVELOPMENTAL DISABILITIES

I. <u>PREAMBLE</u>

This is a contract between the Athens County Board of Developmental Disabilities, (hereafter "ACBDD") and Richelle Frabotta, MSEd, Coordinator of the Dennis L. Carlson Sexuality Education and Sexual Health Studies Center at Miami University (hereinafter "Contractor".)

II. <u>PURPOSE</u>

The purpose of this agreement is to establish payment from ACBDD for specialized observation, consultation and training regarding human sexuality with an emphasis on Individuals with Developmental Disabilities.

III. OBLIGATIONS AND RESPONSIBILITIES OF THE CONTRACTOR AND ACBDD

The contractor will provide specialized sexuality training for ACBDD and select individuals who are served by ACBDD.

These services for individuals will include:

- In home observation of select individuals recommended by the Service and Support Specialist.
- Consultation with team before observation and after observation to further explore educational service options.
- Devise a strategy that supports the individual in learning appropriate ways to express sexuality.

These services for group education for Professionals include:

- Increase medically accurate, research supported and best practices knowledge.
- Regard human differences and actively work toward respectful inclusion.
- Provide resources and supports for further learning.

These services for team consultation and support include:

- Team meeting focusing on the individual's case per outcome identified.
- There may be situations where ACBDD staff need specific information and resources that does not require a meeting, but a conversation.

These services for Parent and Caregivers:

- Potentially expand comfort level of discussing sexual matters.
- Increase medically accurate, research supported and best practices knowledge.
- Regard human differences and actively work toward respectful inclusion.
- Provide resources and supports for further learning.

CONTRACT PROVIDING FOR <u>Video Production</u> SERVICES BETWEEN THE ATHENS COUNTY BOARD OF DEVELOPMENT DISABILITIES AND <u>Jake Washburn</u>

This contract is made between the Athens County Board of Developmental Disabilities, Athens County, Ohio (hereinafter referred to as Board) and <u>Jake Washburn,</u> Citizen of <u>Washington</u> County and the State of Ohio (hereinafter referred to as Contractor)

In consideration of the mutual promises of the parties, the Board and Contractor agree as follows:

- 1. The Board agrees to employ Contractor, as and when required by the Board, to provide <u>Video</u> <u>Production Services</u> for the Board.



an impasse and requesting the assistance of a mediator. The main issue unresolved is wages and subcontracting of work. Mediation is scheduled for May 24, 2018. Update: we held mediation on May 24. We reached a deal with the leadership of the Teamsters. They took the contract back for a membership vote and it was defeated. Therefore, we are beginning the process of fact finding with the hopes that we reach an agreement soon.

- On June 25 and 26, we met with MEORC (Steve Long) to begin the strategic planning process as we develop our three year strategic plan. We have conducted our survey (ended May 15) and we had 171 responses. We have two sets of days scheduled to work set aside for July 31 and Aug 1st.
- We have had multiple meetings with the commissioners regarding the use of space and potential ways to partner between the county and the ACBDD. We continue to explore possibilities and are gathering costs/estimates (pros/cons) as directed by the Board, including meeting with a local realtor. UPDATE: we have received legal guidance, I have met with the local prosecutor, and we will have a list of options and recommendations at the April Board meeting. UPDATE: I met with Commissioner Eliason on May 7th and he will be coming to the June Board meeting to discuss possibilities for the ATCO Building. Update: Lenny will now be coming to the August Board Meeting and will be joined by Zack Saunders from the prosecutor's office to help us address any legal questions that may arise.
- On June 12, I met with the County Auditor, Jill Thompson to provide updates to our budget situation and to discuss new programs. I am very happy to report that for the third concurrent year we will not have to go to the budget commission this summer. They are satisfied with our current direction.

Moves will result in greater options for Ohio residents with development disabilities

By David E. Malloy, Huntington Herald-Dispatch *Published Tuesday, June 12, 2018*

Open Door School in Ironton will move to the Tri-State Industries building in Coal Grove at the start of the 2019 school year, while adult services for the developm Lawrence County will move to two locations in the coming year.

The Lawrence County Board of Developmental Disabilities runs several programs for about 500 county residents with developmental disabilities, including progra Coal Grove and 6- to 21-year-olds at the Open Door School on Lorain Street.

"We are looking at several locations right now throughout the county for adult day services and habilitation services, said Tim Nunnery, director of communication development at the board of developmental disabilities.

Both the programs for adults and for students plan to be in new locations by the end of 2020, according to a news release.

Person Centered Services, which provides services for adults, will stop leasing the Tri-State Industries building in Coal Grove effective Jan. 1, 2019. The agency plan sites in the eastern and western areas of the county, Nunnery said.

The move will allow the agency to offer more options and activities for adults, said Julie Monroe, superintendent of the board of developmental disabilities.

Person Centered Services has performed a tremendous task of providing adult day services to people with developmental disabilities, Monroe said.

"This move really helps them in expanding their services throughout the county to areas that are more centrally located to where people reside," she said.

The building in Coal Grove, which is owned by the board, will undergo nine months of renovations before the students move in, Nunnery said.

It has a one-floor plan to the Open Door School property on Lorain Street which has three floors, according to Monroe.

The board has heard comments for years that the Open Door School needs a new facility "and we've known that our adult services need to be more accessible for said. "This is our big chance to make these changes and improve our programs to reach full potential."

Parents angry as fate of Happy Hearts students still in doubt

Parents of Happy Hearts School students said they're frustrated with administrators' lack of communication surrounding the school's closure and transition, many are still nebulous.

Ashtabula County's Board of Developmental Disabilities and Educational Service Center — the latter of which assumed the board's school operations earlier this y announced it could no longer afford to because a levy failure in November — continue to negotiate on financial particulars, as well as the school's new location.

Concrete details coming out of those private meetings are scarce, leaving parents to speculate and feed the rumor mill. And with only about two months until chil school, administrators admitted they're "running out of time" to strike a deal to continue the board's services for the developmentally disabled.

"I think it is absolutely irresponsible, asinine, ridiculous that we haven't heard from our superintendent once," said Ashley Dulka of Windsor, whose 8-year-old dau Happy Hearts for four years.

"The fact that all of us parents found out (about the closure) through the newspaper and nothing formally has been sent home about the school — it lost a lot of t parents."

She said many Happy Hearts parents didn't officially learn about the closure until their individualized education plan meetings with administrators last month. Du personally reached out to the DD board's Superintendent Anne Zeitler several times since news of the closure broke in December, but has yet to hear back.

Andrew Misiak, president of the DD board, said administrators aren't keeping details from Happy Hearts parents — there simply aren't any to give. Board and ESC to negotiate several issues surrounding the ESC takeover, such as its operations relationship with the county, which owns the Happy Hearts building, and the sch

"School's going to start in two months. We're running out of time," Misiak told the Star Beacon Wednesday. "We know the parents — they're in limbo, and the scho of in limbo. We need to come up with a plan and quick.

"I know (parents are) getting fed up with that same answer — I have to say 'trust the process' or 'trust what we're doing.' It's hard."

As plans stand, the ESC is still looking to move its offices and Happy Hearts students to the former Thomas Jefferson Elementary School along West 13th Street, w purchased in April from the Ashtabula Area City Schools district for \$500,000.

Fred Lemmo of Monroe Center — who said he moved back to Ashtabula County after living in Colorado specifically so his adopted son, now 15, could attend Happ son will likely struggle if forced to integrate into the Buckeye Local School District, which lacks staff dedicated to the developmentally disabled.

"With him only reading at a first-grade level, if he goes to that school, they can't accommodate him," he said, adding that was why they left Colorado and his son's district. "He doesn't understand what they're talking about. That's a waste of time. He's not learning anything.

"I don't need a babysitter. I need someone who can teach him."

Similarly, Dulka said she refuses to send her daughter to Grand Valley Local Schools, though the district's transportation workers have begun preparing for her da many developmentally disabled students, routine and familiar surroundings and teachers are a big part of the learning process, she said.

"This is structure. This is discipline. This is life. These kids don't like to be on vacation — they like to be in school with their teachers," she said. "(The closure) totally wrench in their whole life. It affects every aspect of their life."

Lemmo also has questions about the board's intentions for about \$1 million in Ohio Department of Education funding the DD board is still receiving until the start Happy Hearts.

Though rumors abound that Zeitler intends to funnel that money to the board's sheltered workshop, AshCraft Industries, Misiak

Bill giving boards of DD access to school security grants passes Ohio legis

On Wednesday, June 6, the Ohio Senate voted unanimously to pass **HB 318**, which contains language allocating \$12 million from the state's General Revenue Func used for security upgrades and training by Ohio schools.

As a result of OACB advocacy, the bill's language was amended in Senate committee to explicitly include schools run by county boards of DD. Schools awarded gra the bill will be able to apply the funding to any of the following:

- School resource officer certification training;
- Active shooter or school safety training;
- Student mental health support; or
- Other educational resources or school safety trainings.

OACB began advocating for board schools' inclusion in HB 318 after several members inquired about improved school safety measures following recent events in and Santa Fe, Texas.

The bill has passed both chambers of the Ohio General Assembly and will now head to Governor Kasich for his signature. The association will research steps for th process and communicate them with members at a later date.

Local agencies compete for workers to support people with disabilities

Rochelle Butler said she's had a rewarding three years working at Choices in Community Living supporting people in the Dayton area with developmental disabilit

"I have this passion for helping people and it's a really rewarding feeling," Butler said.

Agencies that support clients with disabilities are heavily competing now to hire and retain employees like Butler, amid what a trade association for the industry h "workforce crisis."

These professionals play a critical role in supporting clients with tasks like transportation, career assistance, in-home care and other kinds of support. But as Ohio rate has fallen to 4.3 percent as of April, competition for workers has heated up and other industries from manufacturers to retailers to nursing homes and more attract employees from a tight labor pool.

Additionally, average \$10.24 per hour wage can make it a struggle to hire and hold on to direct support workers, especially as some retailers and restaurants raise competing levels.

Workforce recruitment and retention is at a crisis level, said Mark Davis, president of the Ohio Provider Resource Association, which represents companies that er support professionals.

"It's a pretty stark reality that we are about 10 to 20 percent short on employees," Davis said.

Davis said it's hard to raise wages, however, when Medicaid is the majority of the agencies' revenue and reimbursements have not kept up with inflation.

In 2013 the turnover rate for direct support professionals was 4 percent. In 2016, turnover had risen to 51 percent. The association stated the cost of turnover for position ranges from \$3,000 to \$5,000, depending on an agency's structure.

Jobs available

Graceworks Lutheran Services, which has about 20 residential homes for people with intellectual and developmental disabilities, is trying to fill about 25 to 30 fullpositions to join its staff of about 350 direct support professionals.

There are 272 people served by Graceworks' day programs, one in Dayton and one in Cincinnati, and 193 people receive residential services from the agency.

It can be hard to compete for employees with manufacturers, which typically pay higher wages. But Jill Brown, recruitment specialist with Graceworks, said that th retail and restaurants for employees, and as a recruiter she said she tries to make job seekers aware that direct support work can be rewarding.

Graceworks starting pay is \$10 to \$11.80 an hour depending on experience, and Brown said they have annual pay increases, full benefits and an employee referra attract and retain employees.

"We're more than happy to train people," Brown said.

Brown said when she searched recently on Indeed.com for direct support professionals positions in Dayton, more than 400 open jobs showed up, which is a lot of employers even assuming some of the positions are duplicate postings.

"That's still a lot of people competing for the same type of employee," Brown said.

Mitchell Snyder, with Montgomery County Board of Developmental Disabilities Services, said he's working with agencies to raise awareness among job seekers ab a career of supporting people with disabilities can be.

The agencies are marketing how the positions can be flexible and for either day or evening shifts, making the jobs a good fit for a range of people looking for extra or stay-at-home parents. Snyder said he previously worked as a direct support professional while he was still in school.

Megan Behnken, who works as a leader with a day program at Choices, she said she's worked in the field since she was 19, including while she was attending Wrig

Behnken said it's important to be in a job where she gets to work with people, and she likes that there are opportunities to move up in the field or get overtime.

"This is my passion. I definitely want to stay in the field," she said. "Right now I'm deciding if I want to go back and get my master's and if I did that it would be to be teacher."

Butler, who works in a residential setting helping residents with day-to-day living, said its rewarding to feel like she is making a difference in the lives of her clients agency she works for also has perks like bonuses and tuition reimbursement since she is a college student.

"I know some people tend to think it's an overwhelming profession and that's why the turnover rate is somewhat high. But for me and a lot of other people, I think outweigh the cons," Butler said.

Department Highlights:

- The quarterly Provider Meeting was held on Thurs. May 24. Topics included:
 - Good Life training for providers
 - Provider input for the Board's 3-year strategic plan
 - Introduction to Provider Guide Plus
 - Waiting List update
 - MEORC on-line Provider Person-Centered Planning & Documentation Training
- Progress continues for 3 gentlemen who will be moving to Athens County as a result of the closure of the Res-Care Middleton Estates ICF in Gallipolis. The men will move to Athens on Thurs. June 28. Echoing Hills will be the new provider.
- On June 3, Tristin Lawrence, Lindsey Bogatay, and Clayton Ray attended a conference on Trauma Informed Care. This is a critical element in supporting people with disabilities and assuring that plans and support teams are aware of trauma issues.
- The FANS Coordinator resigned June 4. Interviews are being conducted to find a new AmeriCorps worker to replace him.
- June 5 MEORC check-in on progress for the SSA Dept. Kaizen process to streamline the ISP. Significant progress has been made:
 - Clean up of SSA shared drive
 - Exploring more efficient uses of technology, including electronic signatures for standard forms, access to scanning in the field to copy documents, mobile hot spots to increase connectivity in the field, examination of electronic record storage options.
 - Development of standardized review tools for quality reviews.
- The SSA Department is finalizing a new Facebook page that will help educate the community about our department and feature stories about individual/families that are achieving positive outcomes! Please feel free to "friend" and share successes! The page is scheduled to go live on July 2.
- Current Imagine transition status 325 of 399 plans have been transitioned (81%). Full transition is due by May 1, 2019.

Job Development

Three New Hires for May

May was another busy month with an ever increasing job development caseload. Three job seekers on my caseload ended the month with a placement.

Angela Carter Job Developer The first job seeker, Warren, found employment that met his job goal at Rocky Boots in Nelsonville. He works at the Boot Factory Grill completing multiple tasks. Warren works independently and



receives weekly follow along services from PersonnelPlus. He continues to do well and has had many compliments from staff and managers at Rocky Boot.



Another job seeker found his second placement through the assistance of PersonnelPlus. We placed Triston in his first job at The Kid's Place in The Plains as a janitor/custodian. Since he wanted more work, he continued with PersonnelPlus to seek another job to meet his goal. We found a job at Mark Porter of Athens as a lot attendant. He is responsible for maintaining the parking lot areas as well as the three other buildings at the facility. Triston also needed minimal job coaching services in order to learn his job tasks and responsibilities and is now working independently with weekly follow along services.

Our final May hire quickly found her job at Walmart in Athens. Joann started her job development services at the end of April and then interviewed and was hired at Walmart on the spot as a cashier. Joann did not require PersonnelPlus for job coaching assistance but has received follow along services.

We now look forward to the warm month of June and the possibility of many more new job placements, essentially creating happy job seekers and business partners throughout the community.

I have been meeting with more business owners and forming relationships promoting PersonnelPlus as a source for businesses to go to for their hiring needs. Some of those businesses I met

with are Wayne National Forest and Brick Street Marketing. We established contact with our local breweries, including Little Fish and Jackie O's. Jackie O's is very interested in working with PersonnelPlus candidates.

<u>On the Job Support-</u>We worked with six individuals in new job placements to ensure they were learning their jobs. Sites included The Kids Place, Donatos Pizza, Green Leaf, Donkey Coffee, Rocky Boot Grill and Mark Porter.

Employee Development- Employee development was done with multiple job seekers. Applications were submitted at Wayne Nation Forrest, Baymont Inn, Class A Sounds, Jackie O's, Ohio University, Athens County Auditor, Burr Oak State Park, and VA Clinic. A job trainer met with each of these people weekly to assist them in their job search. The trainer helped individuals fill out applications both on line and in the community. They conducted mock interviews and researched possible job opportunities.





Since January 1, 2018, the MUI Department has filed 71 Major Unusual Incident investigations.

The MUI Department currently has 14 open cases which break down as follows:

Neglect—2 (1 family and 1 staff PPIs)

Sexual Abuse—1 (acquaintance PPI)

Physical Abuse—1 (boyfriend PPI—charged and arrested for domestic violence)

Law Enforcement 1 (charged, incarcerated, or arrested)

Significant Injury—1 (1, dropped coffee pot, 2nd degree burns on leg while alone, no neglect—---Keurig purchased)

Unscheduled Hospitalization—2 (both medical)

Death—3 (2 expected due to continual decline in health—one in hospice care, 3rd due to respiratory failure as a result of influenza)

Missing Individual—2 (both have history of walking away from residence when upset—IA to rule out neglect)

Rights Code Violation—1 (involved a student not receiving lunch daily due to not completing tasks—investigation is complete but waiting on this report)

Our contracted IA is doing an excellent job with completing her investigations quickly and submitting reports, which is very beneficial to the implementation of prevention plans. Good communication has been fostered between she and the SSA Department to ensure causes and contributing factors and findings are appropriately addressed. I have also heard positive things from agency providers, so I am sure she is representing the county board well in her role.

I conducted an MUI Rule and Client Rights Training for all of the staff participating in the Kids on Campus camp being held at Beacon School. It was well received and involved many people who did not know much about ACBDD.

Athens County Board of Developmental Disabilities Board Submission by Butch Withem Area of Supervision: Facility \ Transportation June 20, 2018

Intro of highlights:

We are happy to report that the transportation for the first day for Kids on Campus (KOC) was a success. We encountered some unexpected construction in Nelsonville, but other than that all went very smoothly. This is always a challenge to restructure our summer routing to include 30 new passengers. Several of the individuals were new to us and lived in areas we had not transported from, but the am trip was a success. The extra passengers required us to add two additional routes, the same as we did last summer.

Issues to share:

After our last ACBDD meeting we discovered that the furniture for the Harper Street project must be included in the project for prevailing wage thresholds. This put the project over the threshold so the project must be Prevailing Wage. Since learning that, we have been receiving new estimates for the project. So far the painting has gone from \$5880 to \$8100. The carpet install went from \$2900 to \$3300. The parking lot extension with a top dressing of stone went from \$26,389 to \$31,389. The parking lot extension with no top dressing of stone went from \$20,889 to \$23,889. The paving and striping went from \$39,020 to \$42, 715 which means this portion of the project must be put out for bid. The low bid on the doors withdrew when we informed of the prevailing wage requirement, and we are still waiting for the other more expensive estimate to be revised. We have not received the revised estimate for the data drops and the doors. We met this morning to finalize the renovation plan for Harper St. and learned that we need to change some if the fixtures in the restrooms and add a water fountain. At that point we decided to contact the architect and determine if an approved plan was necessary for the project. I will have more info at the June meeting.

Other:

We have been working with FoamCoat Roofing to make repairs to the coating on the roof at Beacon. After many attempts and a broken promise from the owner of the company, I alerted our Superintendent of the situation. Kevin referred the situation to the Athens County prosecutor for advice regarding the issue. The roof was installed in late 2004 and carries a 15 year warranty. The coating is failing in several areas, which has caused some minor leaks but the main concern is the damage to the foam. The rubber coating is applied over the foam to protect the foam from the ultraviolet rays of the sun which deteriorates the integrity of the foam. I am hopeful that the contractor will make the necessary repairs but I think they need some encouragement to get the job done.
