Dr. Davis reminded the board that they voted to provide \$8,000 for the Line 7 Pilot, which was for just six months (part of 2019 and part of 2020). The updated letter from HAPCAP explained they received additional funding and that Line 7 would be fully operational for all of 2020. Dr. Davis also provided ridership data in December 2019, 252 (38 with disabilities) rode the Albany line, 659 (109 with disabilities) rode the Nelsonville line. Demko said she was very pleased to hear this.

a. Superintendent, Dr. Kevin Davis (Exhibit 9, Pages 127-136).

Report stands. He highlighted a meeting with Career Connections. That meeting was an initial conversation about transitioning the remaining ATCO employees (those with disabilities) to be Career Connections employees. This item is on the agenda for the next ATCO Board Meeting for discussion. More information is expected in February and March. He added this is a positive step for the employees with disabilities, as they would be a more inclusive arrangement than being employed by ATCO. He also highlighted Breakfast with Santa, which raised over \$3,000 for the school. He praised the staff for such a successful event. He highlighted the Polar Bear Plunge, which raised over \$10,000 for Beacon's PTA. Lastly, he highlighted the fact that the DODD Director Jeff Davis spent the day in Athens; he toured our facilities and asked and answered many questions from staff. This was impressive because it was the first time the state director did this.
