### 2.1. Root Cause Analysis

Harder to serve students with complex needs and their families have not always been encouraged to consider an array of employment assessments over a period of years leading up to graduation. Instead, students have been offered few if any opportunities to determine their skills, abilities, interests as well as supports they would need to be successful in competitive employment. Therefore, many students have returned home after graduation or have gone to segregated day-habilitation centers with minimal opportunities to thrive in integrated community life.
